(THIS WARRANT ARTICLE IS SUPPORTED BY THE SCHOOL BOARD.) (Majority vote required.) (The 2017-2018 amount is included in Warrant Article 3, the operating budget.)

**Article 03:** Shall the John Stark School District raise and appropriate as an operating budget, not including appropriations by special or separate warrant articles and other appropriations voted separately, for the purposes set forth therein, totaling \$13,534,338 (Thirteen Million Five Hundred Thirty-Four Thousand Three Hundred Thirty-Eight Dollars)? Should this article be defeated, the default budget shall be \$13,537,036 (Thirteen Million Five Hundred Thirty-Seven Thousand Thirty-Six Dollars), which is the same as last year, with certain adjustments required by previous action of the District or by law, or the governing body may hold one special meeting, in accordance with RSA 40:13, X and XVI, to take up the issue of a revised operating budget only. (THIS WARRANT ARTICLE IS SUPPORTED BY THE SCHOOL BOARD.) (Majority vote required.)

and further raise and appropriate the sum of \$175,518 (One Hundred Seventy-Five Thousand Five Hundred Eighteen Dollars)for the school year 2017-2018, such sum representing the additional costs attributable to the increase in salaries and benefits over those of the appropriation at current staffing levels? (THIS WARRANT ARTICLE IS SUPPORTED BY THE SCHOOL BOARD.) (This appropriation is in addition to Warrant Article 3, the operating budget.) (Majority vote required.)
